

PROGRAM GOALS 2024

Hope For Life Rwanda

A. Overview

Hope For Life's goal in 2024 is to continue its vision of seeing youth empowered to escape homelessness and families strengthened to holistically thrive.

The program goals outlined in this document outline HFL's approach in holistic, family-centered, and trauma-informed programs to empower each child's unique journey from living on the streets to reintegration in the family and society. This holistic approach is delivered though our three programs namely, the Transitional Program, Family Support & Monitoring Program and Family Economic Empowerment Program

The goal for 2024 is to serve 331 youth and caregivers including 211 current beneficiaries and 120 new. The new beneficiaries are anticipated to be served within the partnership framework the National Rehabilitation Service where HFL can identify children currently experiencing homelessness within three hotspot areas in Kigali. The services provided (see table below) are outlined by program include Counseling, Psychoeducation, School & Family Monitoring, Economic Empowerment and Education Services

Number of youth beneficiaries targeted: 173 (113 current and 60 new) Number of caregivers targeted: 158 caregivers (98 current & 60 new)

Total number of targeted beneficiaries: 331 youth and caregivers (211 current and 120 new)

Note: The 2024 budget is prioritized to focus on the current beneficiaries and the new 60 youth beneficiaries with their caregivers subject to availability of funding.
